(Rye, millet, oats, barley, rice, sorghum, etc.) Gluten		x	Ethyl alcohol manufactured by Greenfield Global is derived from corn as the raw material. Corn contains corn gluten. It should be noted that the gluten in corn is not of a type that harms celiac patients, and that evidence points to corn being safe for celiac patients, as opposed to wheat gluten which some data suggest may harm celiac patients. The ethyl alcohol product is purified by distillation during the manufacturing process, which removes all traces of gluten to the limits detectable by our laboratories (below 0.002g/100mL). We therefore certify that the ethyl alcohol products manufactured and distributed by Greenfield Global, are wheat-gluten free, and are corn-gluten free to below the detection limits described above.
