



## Food Grade Statement

Toluene and Toluene products sold by Greenfield Global USA Inc. are suitable for materials and articles intended to come into contact with food and use in food and beverage applications as specified in following regulations:

## 1. US FDA Code of Federal Regulations:

## 2. European Union Regulations:

- Resolution AP (2004)1 Toluene is included in C. LIST 1 ADDITIVES of resolution AP (2004)1 on coatings intended to come into contact with foodstuffs. To ensure compliance with AP (2004)1, the specific migration limit of 1.2 mg/kg in food or in food simulant must be met.
- Resolution AP (2004)3 Toluene is included in LIST 1 OF SUBSTANCES USED IN THE MANUFACTURE OF ION EXCHANGE AND ADSORBENT RESINS of resolution AP (2004) 3 on ion exchange and adsorbent resins used in the processing of foodstuffs. To ensure compliance with AP (2004)3, the specific migration limit of 1.2 mg/kg in food or in food simulant must be met.
- EUPIA exclusion list (5th Edition October 2007) Toluene is not included in the exclusion list of solvents issued by the European Printing Ink Association.
- Swiss Ordinance 817.023.21 Toluene is listed in 'Annex 6, List of Solvents, Part A: Evaluated Substances' with migration limit 1.2 mg/kg.
